The Golden Door Award has been an IINE tradition for more than 50 years honoring a person born outside the U.S. that has made outstanding contributions to American society. Our annual gala is an occasion that calls us to stand together in celebration of the achievements of immigrants who have played an integral role in our communities, economy, and society.

The award takes its name from Emma Lazarus's words inscribed at the base of the Statue of Liberty: "From her beacon hand glows world-wide welcome ... I lift my lamp beside the golden door."

The mission of the International Institute of New England is to create opportunities for refugees and immigrants to succeed through resettlement, education, career advancement, and pathways to citizenship.




CRISIS RESPONSE

In August 2023, Massachusetts Governor Maura Healey declared a State of Emergency in response to the large influx of Haitian and Central and South American immigrants arriving in the Commonwealth and entering the overburdened shelter system. IINE has become a leader in supporting Haitian immigrants. Today, we are working directly with immigrant families in the shelters to ensure they are able to access public benefits, including food and healthcare, and apply for work authorization so they may secure jobs.

Our History

Founded in 1918 in Lowell, Massachusetts as a community effort to welcome new Americans immigrating to the area, IINE today serves more than 10,000 refugees and immigrants annually, with programs in Boston, Lowell, and Manchester, New Hampshire.



EDUCATION AND WORKFORCE PREPARATION

In 2023, more than 800 immigrant adults enrolled in our English for Speakers of Other Languages (ESOL), job readiness, industry-specific skills training classes, and employment programs. We help adults find employment and offer specialized training programs to prepare those with prior U.S. work experience to secure jobs in the healthcare and construction industries.

REFUGEE RESETTLEMENT

IINE welcomes newly arrived refugees and others who have experience forced migration and supports individuals and families in creating a solid foundation for their life in the U.S. from which to build. Our teams work to help each new arrival secure a home and a job, access healthcare, register and enroll in school, and navigate a new community.

THE EXAMPLES BELOW ILLUSTRATE HOW YOUR SPONSORSHIP DOLLARS CAN CHANGE LIVES.

Your sponsorship immediately impacts the thousands of refugees and immigrants served by IINE every year.

\$500,000

Helps us launch new programming to respond to the critical and emergency needs of thousands of refugees and immigrants forced from their homes.

\$250,000

Supports the food and basic household needs of 200 resettling refugee families.

\$150,000

Supports 40 refugees during their first year in the U.S. by providing access to case workers, essential support services, and English language training.

\$100,000

Provides 50 child survivors of human trafficking with transition support from dedicated licensed social workers.

\$50,000

Contributes to life-changing one-to-one mentoring and skills support for 25 refugee and immigrant youth and young adults.

\$25,000

Helps reunite five unaccompanied immigrant children with their families in the U.S. by providing essential services and access to licensed bilingual case workers.

\$15,000

Enables 45 immigrants and refugees to improve their English and communication skills through classes taught by experienced ESOL instructors.

\$10,000

Helps 15 adult refugees secure employment in New England.

\$5,000

Enables four immigrant families to access free legal services to establish a pathway to citizenship.

\$2,500

Provides a month's worth of food for five newly arrived refugee families.
